IMPORTANT ANIMAL HEALTH NOTES FOR SHEEP AND GOAT EXHIBITORS

PLEASE READ THE FOLLOWING NOTES AND REMEMBER TO SIGN BOTH DECLARATIONS PRINTED ON PAGE 4 OF THIS ENTRY FORM (SECTIONS 18A & 18B) AND ENCLOSE COPIES OF THE RELEVANT SAC OR CAE CERTIFICATES WITH YOUR ENTRIES.

MAEDI VISNA SHEEP - Exhibitors of Maedi Visna Accredited Sheep must declare their status on this form (Section 16) and are also required to send a valid Green SAC Certificate stating the number and type of sheep and the flock registration number with their Entry Form. A fully completed Green SAC Certificate must be presented to the Stewards at the Show before any animals are unloaded.

GOATS - All Goat classes are restricted to CAE negative tested animals. Exhibitors must include a copy of a certificate issued during the previous 12 months with their Entry Form. A current certificate must be presented to the Chief Goat Steward at the Show before animals are permitted to enter the marquee. The Declaration on page 4 of this Entry Form (Section 18B) must also be completed by Exhibitors of Angoras, which are considered to be seasonal breeders.

SCRAPIE APPROVAL FOR SHOWS - Because the Show is held between 1st May and the 31st August DEFRA require female sheep of all breeds, (except **Dorset Horn, Polled Dorset and Finnish Landrace**) to be non pregnant, not to have lambed within 30 days prior to the Show and not be subject to procedures which change the seasonal breeding pattern. However, in addition, **Exhibitors of female Dorset Horn, Polled Dorset and Finnish Landrace breeds and any animals subject to procedures that change the seasonal breeding pattern** must also sign the Declaration on page 4 of this Entry Form (Section 18B).

A new class of membership is Corporate Membership, which is aimed at raising income for the Society and giving businesses an opportunity to reward their staff and customers. The cost is £175 for which you will receive 14 entrance tickets and guest badges, reserved parking and use of the Members' Enclosure.
